#### GENERAL ORDER

In an effort to bring this Court's practices in line with The Supreme Court of Ohio's Guidance to Local Courts – COVID-19 Public Health Emergency issued March 20, 2020, this Court shall not issue capias warrants for failure to appear for traffic violations, minor misdemeanors, and non-violent misdemeanor offenses until after April 6, 2020.
