## Legislative News: Two Week Review

- Judges Hein and Washam developed a model sentencing entry for SB 201 (Reagan Tokes) cases.
- <u>SB 26</u> (Sen. Kunze) **Tax Credits**, passed by the House Finance Committee, 10.10.19. The bill concerns tax credits for teacher supplies, and was amended to include a restoration of a business income tax deduction for lawyers and lobbyists that had previously been removed in HB 166.
- <u>SB 205</u> (Sens. Hottinger, O'Brien) **Animal Cruelty**, introduced 9.30.19. The bill increases the penalties for cruelty to animals (from F5 to F3 or F4). It makes those crimes ineligible for sealing.
- •<u>HB 350</u> (Rep. Hoops) **Animal Fighting and Bestiality**, introduced 9.26.19. The bill prohibits bestiality, arranging animal fighting, or attending an animal fighting event. The bill reenacts these provisions from <u>131 SB 331</u>, which were severed as a violation of the single-subject rule.
- <u>HB 351</u> (Reps. Lepore-Hagan, Sobecki) **Termination of Rental Agreement**, introduced 9.26.19. The bill allows the victim of rape, attempted rape, or domestic violence the right to terminate a rental agreement with a landlord, under specific circumstances and within a specified time period.
- <u>HB 354</u> (Reps. Plummer, Swearingen) **Weapons Disability Portal**, introduced 10.1.19. The bill requires juvenile courts to expunge juvenile records at age 28 (instead of the current age 23); it expands the circumstances under which a person has a weapon under disability; it requires the creation of weapons disability data portal and imposes fines on courts that fail to comply with data submission requirements.
- <u>HB 362</u> (Reps. Lang, Plummer) **Masked Intimidation**, introduced 10.8.19. The bill creates the crime of masked intimidation, an M1. The bill prohibits wearing a mask or disguise in order to obstruct the execution of the law; to hinder a person in the performance of a legal duty; or to prevent a person from exercising constitutional rights.
- <u>HB 366</u> (Reps. Miranda, Plummer) **Child Enticement**, introduced 10.10.19. The bill adds the requirement of an "unlawful purpose" for the offense of child enticement.
- In **State v. Kernall** (2019-Ohio-3070), 7.31.19, the First District found that for purposes of R.C. 2929.15(B)(1)(c), a **"technical violation" of a community-control sanction** is a violation of any requirement which merely facilitates community-control supervision. An offender's significant failure to comply with any substantive rehabilitative community-control requirement that was specifically-tailored to the offender's underlying conduct is a nontechnical community-control violation. It is also a nontechnical community-control violation if the offender engages in a pattern of conduct that demonstrates a failure to comply with the community-control sanction as a whole.
- In **Kentucky v. Dickerson** (Civil Action No.. 19-CI-00425) the Supreme Court of Kentucky **disqualified a judge** because he "liked" a Facebook post supportive of one litigant (who is running for Governor) while a case before him concerned the election. When judges use social media they may have their impartiality reasonably questioned, requiring disqualification.
