ORDER TERMINATING TEMPORARY ORDER  
IN RESPONSE TO THE COVID-19  
(CORONAVIRUS) PUBLIC HEALTH CRISIS

ADMINISTRATIVE ORDER

The Judge of the Brown County Court of Common Pleas and the Judge of the Brown County Municipal Court make the following findings of fact:


1. On May 12, 2021, Ohio Governor Mike DeWine announced that the vast majority of health orders would be rescinded on June 2, 2021 at 12:01 a.m.;
2. On May 17, 2021, Stephanie McCloud in her capacity as the Ohio Director of Health, in response to new guidance from the Centers for Disease Control and Prevention (CDC), issued a *Second Amended Order for Social Distancing, Facial Coverings and Non-Congregating*, effective until June 2, 2021 at 12:01 a.m. unless rescinded or modified.;
3. On June 1, 2021, Stephanie McCloud in her capacity as the Ohio Director of Health, issued an *Order Rescinding Various Orders*.
4. On June 2, 2021, the *Second Amended Order for Social Distancing, Facial Coverings, and Non-Congregating* expired.
5. Based upon the expiration of the Ohio Director of Health's May 17, 2021 order, the protocols set forth in the March 17, 2020 Administrative Order of the Brown County Court of Common Pleas, General and Domestic Relations Divisions and

the Brown County Municipal Court are no longer necessary to protect the health of court employees and the public.

**THEREFORE, IT IS HEREBY ORDERED:**


1. The March 17, 2020 Administrative Order of the Brown County Court of Common Pleas, General and Domestic Relations Divisions and the Brown County Municipal Court, as well as any previous orders of either Court related to the public health crisis are rescinded effective immediately.
2. The Courts will adhere to the February 16, 2021 US Department of Housing and Urban Development's extension of the Moratorium on Foreclosures and Evictions expiring June 30, 2021 and any subsequent guidelines thereafter.
3. Each Judge may set procedures conducive to the functional and operational needs of their respective Court.
