In order to protect the health and safety of court employees and the general public, and to ensure the effective operation of the Court, it is hereby ORDERD:

Effective Immediately:

- 1. All appearances and hearings are limited to attorneys, defendants, witnesses, victims and people making payments. Individuals that do not have business before the Court will not be permitted in the courthouse
- 2. Pursuant to ORC §2945.72(H), all traffic arraignments, unclassified misdemeanors (with the exception of 3rd offense OVI charge), minor misdemeanors and criminal offenses charged as M4 and M3 shall be continued. In light of the current public health emergency, the Court finds that such a continuance is not only reasonable, but also necessary to protect the public health.
- 3. Arraignments, Initial Appearances on Felony charges and other hearings for defendant's being held at the Logan County Jail shall continue to be conducted via video technology on Monday, Tuesday, Wednesday and Thursday mornings at 10:30 a.m.
- 4. All civil and small claims trials, evictions, garnishment hearings shall be continued, as deemed necessary by the Court.
- 5. With the exception of emergency matters, domestic violence hearings and evidentiary hearings in criminal cases, all in-person appearances for civil pre-trials and criminal dockets shall be conducted via telephonic or video technology whenever possible.

- 6. Cases involving an attorney or party who is ill or in a high-risk category shall be rescheduled.
- 7. Defendant's attendance shall be excused from pretrial and scheduling conferences in criminal cases.
- 8. All hearings on civil contempt, show cause, sentencing hearings and debtor's examinations shall be continued
- 9. All persons on Probation shall call the Probation Office at 937-599-3011 to schedule their appointments.
- 10. No person shall be admitted into the courthouse if they have visited any "high risk" countries, as identified by the Center for Disease control and Prevention (CDC) including, but not limited to, China, Iran, South Korea and anywhere in Europe. Additionally, anyone who has been in contact with someone who has been to any of these countries is also prohibited from entering the courthouse.
- 11. The Municipal Court security policies may be temporarily amended or supplemented to protect public health while maintaining essential court functions.
- 12. The Court will have the lawful authority, within constitutional limits, to do and direct to be done all things necessary to ensure the orderly and efficient administration of justice for the duration of the declared public health emergency.

This Temporary Order shall remain in effect until further order of this Court.
