If you are scheduled to personally report to probation, please call your probation officer's extension at (740) 446-9400 to ask if you still need to personally appear or if your appointment may be handled by telephone conference or rescheduled.

IN RE: Temporary Order in Response to the COVID-19 (Coronavirus) Public Health Crisis

GALLIPOLIS MUNICIPAL COURT

Now comes the Court and finds that, on March 9, 2020, the Governor of Ohio declared a "state of emergency" in response to the growing COVID-19 public health crisis. The Court further finds that, on March 12, 2020, the Ohio Judicial Conference recommended that individual courts implement contingency and emergency plans tailored to the conditions in individual communities. The Court further finds that a prudent course of action is to develop a continuum of flexible responses in the event that the public health crisis escalates in Gallia County.

Therefore, with the intent to protect the health of the public and employees, to maintain essential functions, and to ensure the rights of all individuals subject to the authority of the Court, the Court hereby ORDERS:

- All traffic pre-trials may be conducted by telephone followed by the submission of a written pre-trial report to the Clerk of the Court.
- 2. All criminal initial pre-trials may be conducted by telephone followed by the submission of a written pre-trial report to the Clerk of the Court.
- All criminal final pre-trials not involving an individual victim may be conducted by telephone followed by the submission of a written pre-trial report to the Clerk of the Court.
- All civil pre-trials and motion hearings may be conducted by telephone with the Court participating in the telephone conference.

5. All traffic and criminal motion hearings; all criminal final pre-trials involving an

individual victim; and all traffic, criminal, civil, and small claims trials will continue

to be heard as currently scheduled. In the event that the public health crisis escalates,

civil and small claims trials may be continued on the motion of the Court or the

parties, or may proceed with the use of audiovisual devices and technologies rather

than personal appearance.

6. The Court Bailiffs and the Gallipolis City Police responsible for the security

checkpoint at the entrance to the Justice Center are authorized to restrict access to the

courtroom and other areas of the facility. Access may be restricted for spectators and

any persons who display any symptoms of illness. Access may not be restricted for

individual parties to cases, victims, or any subpoenaed witnesses, although

appropriate precautions shall be taken to isolate any person displaying any symptoms

of illness from direct contact with other individuals.

7. The Court Administrator is authorized to temporarily adjust provisions of the Court

Personnel Policy Manual to maintain essential functions.

8. This is a temporary order and will expire on a date certain to be determined by the

Court.
