
This matter comes on for further Administrative Orders with regard to the operation of the Probate Division of the Columbiana County Court of Common Pleas due to the recent increase in positive COVID-19 cases and/or variant strains of the Coronavirus in Columbiana County, in Ohio, and Nationwide. This action is a direct effort to help reduce the spread of the COVID-19 virus and respect social distancing. The Court continues to monitor the COVID-19 pandemic and will implement adjustments and revisions if, and when, necessary. Therefore, the Court makes the following orders:

IT IS HEREBY ORDERED that:

1. Effective August 19th, 2021 and until further orders of this Court, the hours of Operation of the Probate Division of the Columbiana County Court of Common Pleas will be 8:00 a.m. until 4:00 p.m., Monday through Friday.
2. Due to the inability to provide social distancing of the staff of the Columbiana County Probate Court, the office of the Columbiana County Probate Division of the Court of Common Pleas shall be closed to the public during the hours stated above. Personal appearance at the court shall be limited to those of strict necessity. Telephone contact will be available. Masks will be requested to be worn by all persons personally appearing at the court.
3. This Order will be reviewed as necessary and the Court will amend, vacate or continue this Order and adjust according to any future directives received from Governor DeWine's Office, the CDC, and/or the Ohio Department of Health.

4. The Deputy Clerk shall enter the judgment upon the Court's journal and within three (3) days thereafter shall serve upon all parties not in default for failure to appear notice of the judgment and its date of entry upon the journal.

All until further order of the Court.


