FILING DEADLINES REMAIN INTACT, BUT SOME HEARINGS TO BE CONTINUED.

As of Monday, March 16, 2020, the Court of Common Pleas Criminal and Civil Divisions in Auglaize County are operating with only essential staff on-site. The building is open, but only to those who have time-sensitive business with the Court. The Clerk's Office is open and all filing deadlines remain intact.

Some non-emergency hearings may be continued and will be rescheduled as more information becomes available. The attorneys will be notified of any continuance.

The court is authorizing all parties in civil and criminal cases to file pleadings, other than Complaints and pleadings that need to be accompanied with filing fees, by FAX transmission to the Clerk of Courts. That FAX number is 419-739-6768.

Civil complaints and other pleadings requiring a deposit for costs must be filed together with such deposits as normal.
