## Legislative News: Two-Week Review

- <u>SB 25</u> (Sen. Gavarone) **Increased Penalty and New Offense**, signed by the Governor 4.21.22. The bill increases the penalty for drug trafficking if the offense is committed near a drug treatment center. As-introduced, the bill created a new offense of defrauding an alcohol or drug test by using fake urine, adulterated urine, or someone else's urine; that language was removed from the final bill.
- SB 321 (Sen. Romanchuk) Nurses Legal Roles and Immunities, introduced 4.12.22. The bill provides that, just like physicians, certain nurses (certified nurse-midwives, clinical nurse specialists, and certified nurse practitioners) are immune from certain civil suits except in cases of willful or wanton misconduct. A hospital facility is immune from lawsuit if an advanced practice registered nurse fails to obtain informed consent before a procedure (this currently applies only to physicians). Clinical nurse specialists and certified nurse practitioners are authorized under this bill to provide information to the court in competency proceedings, to conduct blood tests to determine the paternity or identity of a person, and to provide an excuse for someone from jury duty (currently roles limited to physicians).
- <u>SB 322</u> (Sen. Hackett) **Sex Offenses,** introduced 4.12.22. The bill applies Sec. 2305.111 (civil suits concerning childhood sexual abuse) to violations of Sec. 2907.05 (gross sexual imposition) and 2907.06 (sexual imposition) if the victim is the patient of a licensed medical professional who violated the law during the course of treatment; the bill outlines what records are admissible as evidence in a civil suit. The bill also creates a new criminal offense of failure to report a crime if a person who knows or has reasonable cause to know that a licensed medical professional is committing a sexual offense does not report it within 30 days; the crime is an M4.
- <u>HB 626</u> (Rep. Patton) **Motor Vehicle Offenses**, introduced 4.20.22. The bill increases the penalty for "failure to comply with order or signal of police officer" and authorizes forfeiture of the vehicle.
- <u>HB 628</u> (Reps. Upchurch, Weinstein) **Regulate Recreational Marijuana Use**, introduced 4.20.22. The bill is the result of an initiative petition that would regulate recreational marijuana use and sales similarly to alcohol use and sales.
- On 4.18.22, the Ohio Public Defender issued a <u>memorandum</u> with an update on the indigent reimbursement rate, which the OPD is forecasting will be 90% for FY23.
