On behalf of all your colleagues in the state judiciary I offer our gratitude to you for your service, your dedication to the profession, and your contribution to the social fabric we all labor to maintain as the judicial branch of state and local government. Remember that even in retirement you can continue to contribute, either through judicial assignment or through participation on an OJC committee. Your experiences and knowledge continue to be valuable.

Judge Teodosio is a tireless advocate for children in Ohio. She believes the juvenile court system can have a positive impact on a child's life, and also believes the system needs to give every child every chance to receive the guidance necessary to return to society as a contributing member, with a renewed outlook toward achieving a better

quality life. She feels strongly that the juvenile courts must assure that the children who come before it take responsibility for their actions, but the courts must also be responsive to their needs so they can avoid further exposure to the juvenile justice system. She has created an inviting, welcoming space to encourage young people to read."



OHIO JUDICIAL CONFERENCE NEWS

ENACTMENTS DURING THE FINAL DAYS OF THE 129TH GENERAL ASSEMBLY

During the final days of the 129th General Assembly, the following bills of interest to Ohio courts and judges were enacted. Information about these new laws, as well as their effective dates, will be available on the OJC website at www.ohiojudges.org.

House Bill 27: Adult Guardianship. House Bill 27 adopts the Adult Guardianship and Protective Proceedings Jurisdiction Act. It will facilitate inter-state transfer of guardianship agreements and authorize conversations between judges in Ohio and their counterparts in other parts of the United States. **EFFECTIVE: March 22, 2013**

House Bill 62: Judicial Assault. House Bill 62 authorizes enhanced penalties for assaults on health care professionals and justice system personnel including up to a \$5,000 fine when the offense is a M1; limits the application of the new law to circumstances where the offender knew or had "reasonable cause" to know that the victim was a health care professional or justice system personnel and instances where the victim was engaged in the performance of the victim's duties; increases the penalty for assaults on health care professionals and justice system personnel from the M1 to an F5 for repeat offenders; defines the felony assault on health care professionals or justice system personnel as a "qualifying assault offense" and states the conditions for imposing prison terms for these offenses. **EFFECTIVE: March 22, 2013**

House Bill 197: Unpaid Fines or Costs. House Bill 197 requires municipal, county, or mayor clerks to pay collected moneys before the twentieth day of the month; authorizes municipal and county courts to require community service in lieu of costs or to allow payment of costs in installments if at the time of sentencing or at any time thereafter the court finds that the offender cannot pay costs or cannot pay costs in full; ensures that after notice to the debtor and an opportunity to enter into an installment payment or community service agreement with the court neither the Registrar

of Motor Vehicles nor any deputy registrar accepts any application for the registration or transfer of registration of a motor vehicle of a person who fails to pay any fine or costs imposed for offenses by a common pleas, municipal, county, or mayor's court; raises from \$3 to \$6 the ceiling on optional additional fees that a court of common pleas may charge to fund court computerization or computerized legal research services; raises from \$10 to \$20 the ceiling on optional additional fees that a court of common pleas may charge to make technological advances or to computerize the court clerk's office; caps at \$1 the increase that courts can charge for certain services described in section 2303.20; requires a court in determining the sentence for a criminal offense to consider emotional, mental, or physical conditions traceable to an offender's military service that contributed to the offender's commission of the offense and to consider the offender's military service record; and makes other changes. **EFFECTIVE: March 22, 2013**

House Bill 247: Court Costs. House Bill 247 responds to State v. Clevenger (2007) by expanding the authority of a sentencing court to waive, suspend, or modify payment of the costs of prosecution; codifies City of Middleburg Heights v. Quinones (2007) by defining case as "a prosecution of all the charges that result from the same act, transaction, or series of acts or transactions and that are given the same case type designator and case number under Rule 43 of the Rules of Superintendence for the Courts of Ohio or any successor to that rule;" renames the "Chief Justice of the Court of Appeals" the "Chief Judge of the Court of Appeals;" provides that a principal in a power of attorney may nominate a guardian of the principal's incompetent adult children; and enacts other changes. **EFFECTIVE: March 22, 2013**

House Bill 278: Financial Responsibility. House Bill 278 makes changes to the law governing automobile insurance policies and, among other things, increases the minimum amounts required for valid proof of financial responsibility. Section 3(A) effective 9-22-13; Section 3(B) effective 12-22-13; all other sections effective 3-22-13;

EFFECTIVE: March 22, 2013

House Bill 279: Child Custody. House Bill 279 eliminates the automatic termination upon the expiration of one year of a power of attorney or caretaker authorization affidavit that gives care of a child to a grandparent; creates a 14-day cooling off period to allow grandparents to petition the court to obtain permanent custody if the child's parent seeks to terminate a power of attorney or caretaker authorization affidavit. **Section 6 effective 3-21-13; all other sections effective 12-20-12;**

EFFECTIVE: December 20, 2012

House Bill 380: Asbestos Exposure Compensation. House Bill 380 requires claimants in asbestos tort actions to make certain disclosures pertaining to asbestos trust claims that have been submitted to asbestos trust entities for the purpose of compensating the claimant for asbestos exposure. **EFFECTIVE: March 27, 2013**

House Bill 461: Family Law Collaborative. House Bill 461 establishes a collaborative family law process to resolve family law disputes; clarifies when an order of spousal support may be modified; and clarifies the circumstances under which a client's statements may compel an attorney to testify regarding attorney-client communications. **EFFECTIVE: March 22, 2013**

House Bill 479: Trust Code. House Bill 479 adopts the Ohio Legacy Trust Act; grants probate courts concurrent jurisdiction over certain transfer on death accounts; and makes other changes. **EFFECTIVE: March 27, 2013**

House Bill 495: Concealed Handgun. House Bill 495 makes changes to the statutes governing concealed handgun licenses. **EFFECTIVE: March 27, 2013**

House Bill 606: Youngstown Municipal Court. House Bill 606 abolishes a judgeship of the Youngstown Municipal Court; increases from more than 100 to more than 200 the population necessary for a municipal corporation to have a mayor's court; and provides that a conviction or guilty plea for texting while driving and a substantially equivalent

municipal ordinance for the same conduct are allied offenses of similar import and that an adjudication for the offense of a person who is less than 18 years of age from using, in any manner, an electronic wireless communications device while driving and an adjudication of a substantially equivalent municipal ordinance for the same conduct are allied offenses of similar import. **EFFECTIVE: March 22, 2013**

Senate Bill 70: Arson Registry. Senate Bill 70 establishes a registry for arson offenders. EFFECTIVE: July 1, 2013

Senate Bill 114: Motor Vehicles. Senate Bill 114 establishes conditions for the operation of certain specialized motor vehicles and, among other things, establishes civil liability for installing nonconforming glass or other material, including costs and attorney fees; gives the Franklin County Court of Common Pleas exclusive jurisdiction over motor vehicle repair registration violations. **EFFECTIVE: March 22, 2013**

Senate Bill 160: Sentencing Laws. Senate Bill 160 requires automatic notice to victims of aggravated murder, murder, first, second, or third degree felony offenses of violence, or offenses punishable by a sentence of life imprisonment of certain prisoner or alleged juvenile offender release or transfer proceedings unless the victim has requested that the notice not be provided; provides that voluntary manslaughter committed with a sexual motivation is a sexually oriented offense, makes an offender or juvenile offender registrant who commits it a tier III sex offender/child-victim offender, and may qualify a juvenile offender registrant who commits it as a public registry-qualified juvenile offender registrant; waives the notice by publication requirement for a change of name if the applicant submits proof that the publication would jeopardize the applicant's personal safety; revises the sentencing options for fourth and fifth degree felonies. EFFECTIVE: March 22, 2013

Senate Bill 298: Entertainment Districts. Senate Bill 298 alters the conditions under which a D-51 liquor permit may be issued. EFFECTIVE: March 22, 2013

Senate Bill 301: Controlled Substances. Substitute Senate Bill 301, among other things, makes changes in the classifications of certain controlled substances.

EFFECTIVE: March 13, 2013

Avoiding Scheduling Snafus in the Digital Age

Some courts have embraced the multiplex technological advances produced to assist courts in recent years. Some courts, and some judges, have less enthusiastically been forced to accommodate such advances. Many courts allow filing via e mail. Many have computerized all aspects of court business, from file retention to probation and everything between, beneath, and beyond. These advances have saved time and money, increased efficiency, and afforded more user-friendly means to serve citizens. But with such advances come potential hazards of which each judge must be aware.

Of specific concern for the judge is the interface of his or her own personal calendar with that of the court. The importance of keeping the judge's personal calendar, schedule, and the like separate from that of the court is heightened with the advent of online dockets, internet search engines, and various mobile applications which allow access to court records. Many of these new technologies enable a judge to merge the court's calendar into the judge's personal calendar. But the opposite is true as well, and that is where problems can arise.

Cautious oversight is urged to prevent a judge's personal schedule from merging with and appearing on the court's official schedule or docket. Instances of such errors are easily imagined: the court's docket might include a notation of the judge's attendance at a political function, scheduling of a medical procedure, family vacation plans, participation in a charitable event, and the like.

A judge's political activities are regulated by Canon 4 of the Ohio Code of Judicial Conduct. But when a judge's participation at a political function calls into question the judge's independence, integrity, and impartiality, obvious problems arise, the least of which, sometimes, is the mere appearance of impropriety. Ohio's maintenance of a popularly elected bench increases such concerns.

A judge's participation at a charitable or similar event might create an impression the judge's favor can be curried by a litigant or attorney who voices strong support of the same cause. The strictures of Canon 3, while understood by the bench and bar, might not be as well understood by the general public.

Where a judge's publication of his or her extra-judicial schedule does not raise ethical considerations it certainly raises security concerns. In a May 15, 2012 letter to the State Fair Political Practices Commission, the California Judges' Association cited the following startling statistic: "[o]n average, a judicial officer in the United States is killed every 36 months; this underscores the very real risks faced by judges." We all recall the 2005 attempted assassination of a federal judge in Chicago that resulted in the death of the judge's husband and mother. That event followed the killing of three federal judges since 1978. The U.S. Marshal's Service undertook a study of the factors surrounding those tragedies and found the following: (1) all attacks happened as a result of involvement over a specific court case; (2) none of the assailants made a threat prior to the attack; (3) all attacks occurred away from the courthouse; and (4) three of the attacks stemmed from civil cases. (Muffler and Brandlin, *Judicial Security*, Case In Point (2011 Issue), a publication of The National Judicial College.) Thus, statistically, we as judges are at greater risk away from the security provided to us in the courthouse. To maintain our own safety, as well as that of our families, it is imperative that our outside activities, of whatever nature, not be broadcast. Therefore, a judge's inclusion of personal activities in a published court docket places the judge at risk. Judges should ensure that their personal calendar does not mistakenly end up on the court's official website, mobile app, or electronic docket.

2012 ODYS COMMUNITY RECOGNITION AWARDS

In partnership with the Ohio Association of Juvenile Court Judges and the Governor's Council on Juvenile Justice, the Ohio Department of Youth Services (DYS) presented the Fourth Annual Community Recognition Awards on December 6, 2012. The presentation highlighted youth who have done an outstanding job of turning their lives around and recognized community partners for providing valuable services to youth.

In August 2012, DYS began the call for nominations for the awards, and agencies from all over the state responded with recommendations of many successful youth and notable community programs. A committee composed of judges and staff, children's advocacy groups and DYS staff reviewed the nominations and had the challenging task of narrowing the selections to be highlighted at the presentation. Six deserving programs and six exemplary youth were selected.

The Linda Modry Young Woman of Achievement Award was given in honor of Linda Modry, who retired in 2011 as Deputy Director of Parole and Community Services at DYS. Throughout her career, Linda was passionate about seeing youth, especially young women, succeed. She was a key to the agency creating and preserving collaborative relationships with juvenile courts and community programs.

The Alternative to Detention (ATD) Program, which is part of the Scioto County Juvenile Court, received the Linda Modry Young Woman of Achievement Award. ATD helps address issues that youth and their parents face by targeting youth along with their families. The 10-week program operates each Saturday and includes academic tutoring and gender-specific groups that address issues including drug and alcohol use, peer affiliations, healthy relationships, gangs, pro-social behavior, diversity, truancy and more. Youth are transported to the program and, at lunchtime, parents join their youth for lunch and then stay for a parenting class.

Youth Raqueal also received the Linda Modry Young Woman of Achievement Award. The 17-year old was a participant of ATD. At one time she faced many obstacles including living on the streets and struggling with self-control. Raqueal and her new guardian Bridget were enrolled in ATD and learned to communicate more effectively. Bridget gained parenting skills, and Raqueal began turning her life around. Now Raqueal attends the Scioto County Career Technical Center, where she is majoring in criminal justice and maintains an A-average. She has volunteered in her community and plans to attend college next fall.

The Mahoning County High School received a Community Recognition Award. This public community school offers an educational opportunity to students who desire to get back on track with their academics. Students receive the chance to re-engage in school and obtain a high school diploma while also developing healthy relationships with adults who care for their well-being. Mahoning County High School offers assistance in obtaining employment, enrolling in post-secondary education programs and referrals to any services that might benefit youth.

A very special participant of Mahoning County High School, youth Steven also received a Community Recognition Award. Stephen's father passed away when he was young, and he lived with his mother at the time of his enrollment at Mahoning County High School. When Stephen began attending Mahoning County High School he was quite reserved but, in time, he engaged in multiple programs including two consecutive years of participation in Kent State University's Alternative Spring Break, which provides service work for organizations in need in Columbiana County.

During his second year participating in the Spring Break Program, Stephen received word that his mother was ill and needed him to come home early on the final day. Within weeks, Stephen lost his mother and became responsible for maintaining a home and caring for himself at the age of 17. Eventually, Stephen moved into his aunt's home. Through everything, Stephen maintained a positive attitude. He decided to return to his home school, but he maintains contact with staff at the school and plans to attend the alternative Spring Break Program again in 2013. Staff describe him as "loyal, honest, hardworking, outstanding and a survivor."

The Altercrest Day Treatment Program, a part of the St. Joseph Orphanage, received a Community Recognition Award. Youth attending the Altercrest Day Treatment Program are often referred because of difficulties in a traditional school setting. The Partial Hospitalization Program provides assistance with mental health, social and independent living skills and education. The Altercrest Day Treatment Program offers vocational skills and independent living classes to help youth make positive life choices and give back to the community.

A young man named Ronzell also received a Community Recognition Award. Ronzell attended the Altercrest Day Treatment Program and took advantage of the opportunities it had to offer. Despite some adverse situations, Ronzell successfully completed the program and went on to become a successful student athlete at Anderson High School. He has since graduated and is now attending Cincinnati State, where he is pursuing a degree in Nursing.

The J. Thomas Mullen Achievement Award is given in memory of Mr. Mullen's outstanding dedication to Ohio's youth. Tom was the second Director of DYS, President and CEO of Catholic Charities in Northeast Ohio, and Chair of the Governor's Council on Juvenile Justice. Mrs. Julie Mullen and daughter Maggie Ford helped present the awards in Tom's memory.

The J. Thomas Mullen Achievement Award was presented to the Community Integration and Training for Employment Program at the Lucas County Juvenile Court. The CITE program provides job readiness training, linkage to employment and community service activities. In collaboration with many public and private organizations, the CITE program helps prepare youth for the world of work by helping them develop the skills they need to find and

keep a job. Skills gained include time management, teamwork, decision making, admitting mistakes, accepting critical feedback, problem solving, effective communication and interviewing skills.

A youth named Eric, who was a participant in the CITE program, also received the J. Thomas Mullen Achievement Award. He quickly began changing the direction of his life by working beyond program expectations. Eric enrolled in a leadership program through Toledo GROWs and was given the opportunity to take initiative in some work projects. He served as a leader among his peers, redirecting them and encouraging them to avoid negative influences on and off the job. After completing leadership training, Eric was hired as an intern through Americorps and also enrolled in Owens Community College to study social work. He also started his own lawn business to earn money for school, and he hired youth in the community who needed work and served as a positive role model for them. In 2012, Eric was hired as a job coach by Toledo GROWs to teach what he has learned about employment and life skills to new recruits.

The Thomas J. Stickrath Reentry Award was given in honor of Tom Stickrath, the former Director of DYS and current Director of the Ohio Bureau of Criminal Investigation. From his time as Assistant Director of the Ohio Department of Rehabilitation and Correction to his years as Director of DYS and in his role today, Tom has been passionate about promoting successful reentry for adults and youth, reducing recidivism and enhancing public safety. Tom was on hand to present the Reentry Award named in his honor.

The Thomas J. Stickrath Reentry Award was given to the Allen County Juvenile Drug Treatment Court. The Allen County Juvenile Drug Treatment Court provides a continuum of strength-based services to juveniles and their families, resulting in healthier family and community relationships, while maintaining accountability and promoting public safety. In partnership with a variety of community agencies, the court uses a model with three phases that lasts approximately 1 year. The program combines intensive level probation, supervision, and case management and treatment services.

Jayden was a participant in the Allen County Juvenile Drug Treatment Court, and he also received the Thomas J. Stickrath Reentry Award. At one time, he was headed down a destructive path and spent some time in a DYS facility. Jayden immersed himself in the Allen County Juvenile Drug Treatment Court, completing all requirements, sessions and treatment. He also provided so much community service at the Literacy Council that the staff there began thinking of him as one of their own. Jayden completed his GED and registered at Rhodes State College at age 17. He continues to study there and has a double major in Network Security and Criminal Justice. Jayden exemplifies the mission and purpose of the Juvenile Drug Treatment Court, and he reminds others of what someone can do if given a second chance and the needed support to get through the rough spots.

The Director's Award was given to Prodigy, Medals in the Making. Prodigy is a state-of-the-art gym located in southwestern Ohio and has partnered with the Montgomery County Juvenile Court Community Based Services program to provide at-risk youth with free accessibility to the largest workout facility in the area. Participants have the option of training in boxing, wrestling, martial arts, mixed martial arts, and fitness/weight lifting. Prodigy, Medals in the Making is designed to help youth by teaching them about self-discipline, accountability, integrity and spirituality. The program provides refuge to many youth and helps them gain self-esteem and discipline, learn different diet and exercise strategies, reduce stress and gain a healthier lifestyle.

Youth Joshua also received the Director's Award. In the past, Joshua was struggling is his classes and was known as the "class clown." Through the intervention of his probation officer and the Prodigy program, Joshua was transitioned from an unfavorable living arrangement to a more structured and healthy environment. Joshua became involved in the Medals in the Making boxing program and learned how to manage anger, accept constructive criticism and praises, and develop his self-esteem. Joshua transformed his life. His grades drastically improved, and he is
