Witnesses



2. All persons entering the Courthouse **shall be required to wear a mask** and are subject to having their temperature taken. All parties shall be required to use the provided hand sanitizer upon entering the Courthouse. Anyone who refuses to do so will be asked to leave and may be deemed to have failed to appear. Anyone with a body temperature of 100 degrees or more shall be asked to leave and seek medical attention.
3. Social distancing shall be maintained at all times. **All parties**, including attorneys must remain at least 6 feet away from each other.

GENERAL ORDER

In light of Governor DeWine's easing of the Ohio Stay at Home order, effective May 4, 2020 all employees shall report to work for normal hours. Employees shall continue to be required to take their temperatures every morning and shall maintain a distance of six feet while at work. Only one person shall be allowed in the copy room at a time. Employees are encouraged to but at this time shall not be required to wear a mask during business hours except when dealing with the public.
